- 1. Approve Meeting Agenda (Consultation) Karissa Morehouse approved
- 2. Approve Meeting Minutes for June 26, 2018 (Consultation) Karissa Morehouseapproved
- 3. Elect chair(s) for 2018-2019 (Consultation) Karissa Morehouse)- *Karissa Morehouse* and Cheryl Aschenbach voted as co-chairs approved
- 4. Set meeting schedule for 2018-2019 (Consultation) –Karissa Morehouse Board meetings are on the second Tuesday of each month and the agenda will not go out until Thursday the week before, so we miss reviewing the board agenda. Suggestions are to move consultation council to the second and fourth Monday. We will propose it at our next meeting on September 5th, 2018 to vote on.
- 5. Proposed LCC Guided Pathways structure (Consultation) Karissa Morehouse We, as a guided pathways team, are looking to create task forces on campus that will move ideas forward quickly so we can keep making the changes we need to make to be successful. We are moving away from the idea of "committee" and are going more towards "task forces" that have multiple constituent groups represented in the task force groups.
- 6. DRAFT Shared Governance Handbook (Consultation) Karissa Morehouse- *committee* needs to work together to update, make changes and approve by September 14, 2018.
 - a. Needs committee meeting schedule (2x/month) by 8/31 –We do not typically have a meeting in August because we are too busy. We, as a campus, need to create a meeting schedule of when our committee meetings will be held and they need to be turned into Karissa and Cheryl by 8/31/18. We have to be meeting consistently to go over this master plan process. We will be holding firm to that this year. We need your proposed meeting dates from the chairs for each master planning group. Minutes and agendas from all master planning meetings will be on BoardDocs and then a link will be on the portal. We will be trained on BoardDocs. in October.
 - b. Needs committee charges reviewed and approved by committees by 9/14 ASB might not be able to have their changes ready by then. Agreed to have committee changes reviewed and approved by committees by 9/14/18. Senate did assign but it might not have been sent out.

- c. Needs updated flowcharts, cycles, and diagrams (WHO?) *Patrick Walton and Randy Joslin will discuss who is responsible for these items.*
- d. Consider proposed language re: standing governance and operational committees and other groups- *There was a question about the committees not* having to follow the Brown Act? Brown Act usually applies to Governing Officials. The agenda and the minutes are used to report out to the campus. At the bottom of the list states who these groups report to. The agenda and minutes will also be on BoardDocs. How are these committee members getting appointed? On page 12 it says "2 CSEA members" but on the other page it states they are appointed by "virtue of their unique expertise or their position they have within the college". This sounds like it is a working group or task force, not a committee. If it is a committee then we have participatory governance involved. There are needs for the participatory governance with health and safety. It may need to be stated what type of group it is to know whether participatory governance is involved or not. Maybe the names need to be clarified. Another concern is will CSEA still have two representative? Yes, they will. Just to note there are two page 11 and two page 12 in the book. We need bring this back to our next meeting after talking with our constituent groups. We can then define what is a committee? What is a task force?

Strategic Planning

1. Update/Recap: Strategic Planning Retreat August 2-3rd (Information)- Karissa Morehouse- The retreat was relocated to GSR in Reno, NV due to bad air quality from the fires. There was 27 individuals from campus (23 staff, 1 board member and 3 students) plus 7 people from the Edoptics team. You will be hearing more about this throughout campus because it relates to Guided Pathways. We were able to have honest conversations and make bonds. We worked on the four pillars in guided pathways and we created action items. Dr. Hall is still waiting on the summary from the Edoptics team. How do we keep the conversations and momentum going? We are going to be having two meetings a semester. Could we do a poll to see when would be best for everyone to go? There is a possibility of doing a 3 day event on campus (1 ½ days for one group and 1 ½ days for the other group). Constituent groups are asking about the framework and funding around Guided pathways so we need to bring it back to their groups. Paperwork about Guided Pathways was sent out to everyone's email. It is called "Guided Pathways Demystified." It helps breakdown Guided Pathways.
