Guided Pathways Team Presentation: Adam Runyon spoke to the Foundation Board about the Guided Pathways project on campus, that it is a statewide initiative (includes career pathways and education plan in the initiative). Our role in this initiative as an institution-to get students on that path to success. Asking the Foundation for funding, the initiative is in need of student voices (we lack student voice in the initiative), currently we have student ambassadors. But, the Guided Pathways Initiative needs more students involved. The need is for 4 students to be involved in the Guided Pathways meetings (2 meetings per month) and a stipend to be paid to the students in the amount of \$456 per month as an incentive to attend the meetings and voice student concerns. Another possibility is to award them a meal card for food in the cafeteria. They are looking to start this in the 2019-20 school year.
