#### AJ-58 Perishable Skills for Peace Officers

# I. Catalog Description

This Course is designed for current peace officers to meet California Peace Officer Standards and Training (POST) mandated bi-annual perishable skills training requirements. Students will receive refresher knowledge and skills in officer safety, proper and safe firearms handling, storage and cleaning techniques, proper and safe tactical movement, arrest and control techniques, safe and efficient driver awareness techniques, and effective verbal and non-verbal use of force and/or communications used in policing. Enrollment limited to current California peace officers. Course instructor signature required for enrollment. Material fees of \$10.00 per student collected at time of registration. Course may be repeated as needed for recertification.

**Recommended Preparation:** Successful completion of ENGL105 or equivalent multiple measures placement.
