## **AJ-61 Juvenile Corrections Officer Core Course**

9.0 Units

## I. Catalog Description

The Juvenile Corrections Officer Core (JCO) course presents the required training for entry level juvenile corrections officers as mandated by the California Standards and Training for Corrections (STC). Topics include: the criminal justice system and process, professionalism and ethics, gangs, communication, security, booking receiving and releasing, supervising juveniles, medical issues, report writing and record keeping, classification, cultural awareness, emergency procedures, visitation, transportation, testifying in court, case planning, programs, assault and abuse, defensive tactics, restraint techniques, and behavioral health. This course is an intensive course designed to provide the basic concepts and skills for the entry-level Juvenile Corrections Officer position in the State of California. This course is required for all California Juvenile Corrections Officers within 12 months of initial employment. A portion of this course is designed to provide practical hands on training in defensive tactics and physical fitness, and participants will engage in physically demanding classroom training exercises that includes a potential risk of injury to the participants. Students need to be prepared for the rigor of the physical fitness and defensive tactics training. Pre-existing medical conditions may interfere with successful completion of these sections and/or the course. Course instructor signature required for enrollment. Material fees of \$50.00 per student collected at time of registration.

**Prerequisites:** Must be 18 years of age and have High School Diploma or GED.

**Recommended Preparation**: Successful completion of ENGL105 or equivalent multiple measures placement.

- 12. Show proficiency in defensive tactics skills as outlined in the California Juvenile Corrections Officer Core Manual.
