#### **U.S. PERMANENT RESIDENTS:**

- Original Alien Registration Card (I-151, I-551)
- Your Passport, valid through first day of classes, "Processed for I-551" stamped including a copy of the picture identification page
- Your Departure Record (Form CBP I-94), valid through first day of classes, stamped showing the expiration date, or stamped "Temporary Form I-551" showing the expiration date

**OTHER ELIGIBLE NONCITIZENS:**

- “Arrival-Departure Record” (Form I-94),” Processed for I-551” with a stamp indicating one of the following:
- Refugee
  - Asylum Granted
  - Indefinite Parole and/or Humanitarian Parole
  - Cuban-Haitian entrant, Status Pending

**Note:** You are **NOT ELIGIBLE** to receive Federal Financial Aid if you are or have a letter that states that you are one of the following:

- An applicant for permanent resident status and not in a category listed above
- A student with an F1 or F (student), J1 or J2 (exchange visitor), L or G series visa
- An applicant under the “Voluntary Departure under the Family Unity Program” (effective 1997-98)
- Undocumented
